## **GUIDELINES FOR LONG TERM CARE**

### **I. Admission Information**

- A. Prior to Admission the facility must receive the following information:
  - 1. An admitting diagnosis, Medication orders, rehabilitative potential and physical examination from the primary care physician signed and dated no more than 30 days prior to admission.
  - 2. Payment of the room and board charges for the remainder of the month at the current daily room and board rate.
  - 3. All admission papers signed by the responsible party, Durable Power of Attorney, or legal guardian, as well as copies of Medicare, Medicaid, and/or other insurance cards and advanced directives. Please make sure that that you bring your insurance cards and advance directives upon admission.
- B. Each resident must be seen by his or her primary physician upon admission, once every 30 days for the first 90 days, and at least once every 60 days following, as required by federal law.
- C. Admission is suggested to be Monday-Friday: 8:00 a.m.–2:00 p.m.
- D. Clothes should be marked with the resident's first initial and last name in waterproof ink. Laundry is free of charge. If a family member chooses to do a resident's Laundry, an airtight container must be provided and laundry picked up at least twice a week.

### **II. Helpful Information**

- A. Spouses are permitted to share a room, unless deemed inappropriate for the overall well-being of clients by the facility care team and medical director.
- B. Visitors are welcome 24 hours.
- C. Mail should be addressed to P.O. Box 157, Ozark, MO 65721. Packages should be sent to 1200 W. Hall, Ozark, MO 65721.
